### □ Process - ② Agency's Record Management

#### Dataset record management criteria table



**① Change management**  
Update in case of a change including system upgrade, data structure, etc.

**② Criteria table management**  
Keep the contents of criteria table up to date

- Change management**
- Reflect the changes in datasets, functions, Systems)
  - (Major changes) SW/HW and Add. Tables, data fields, etc.

- Criteria table management**
- Maintaining the D.M.Criteria Table
  - Notice to Nat. Archives about manor changes and reviews

Keep the process (registration, disposal...), Efficient Procedure (volume disposal..)

## II Process of Dataset Record Management

### □ Process - ② Agency's Record Management

#### Dataset Management



**① Generation**  
New data generation such as data input, link, etc.

**② Operation-refer.**  
Utilize for business, participate in records mgmt. (Fix data in ref. phase)

**③ Preservation**  
Store data which is no longer in operation or split it for storage

**④ Disposal-trans.**  
Dataset disposal, transfer (including org./System abolition)

**Service**  
Records services for the public (stable/efficient)

**Creation**

- Create new data by entering or linking input from another sys.
- automatically classified and compiled according to the control unit at generation

**Operation-Refer.**

- Adding, modifying and using the dataset for business and control of the changes
- No more changes in dataset, fixation is recommended (CRMX change/at least log. files)

**Preservation**

- Store data which is no longer in operation or split it for storage
- Save as Preservation package

**Disposal-Trans.**

- Disposal based on system abolition, work closure, retention period, etc.
- The dataset transfer shall be agreed upon method, time, scope,.. In advance

#### ① Monitoring

Dataset records management

#### ② Criteria table management

Criteria table input,  
confirmation, change,  
access control

Monitoring

- Monitoring of the overall dataset management of the creation agency
- Support the dataset creation agency by inspection, verification & feedback

Criteria table  
management

- Manage the input, confirmation, change & access control of the D.M.C.Table

Acquisition

- acquisition by important national data, abolition agencies, agency requests, etc
- Confirm the transfer, collaborate the size, standard, timing & method(migration, emulation, etc.)

Preservation

- preservation by Package form(like SIARD)

Access Service

- Dataset Archiving Management Sys.(service)



### Dataset Record Management Criteria Table (DMC table)

Objective

Efficient management of diverse administrative datasets

Function

Presenting information on system, data, business, records management (unit function, retention periods, reason) etc. for records management of dataset

Operation

Preparation in system unit, and updating changes






## Dataset Preservation tools(SIARD\_KR)

Develop by Swiss Fed. Archives(Enter AG, 2008) / RODA project(Swiss & EU, Keep co.)


RDB(DBMS)  XML-base folder & files in One Zip(\*.siard)
